#### MEMORANDUM OF UNDERTAKING

I / We Mr. / Mrs. parent / guardian and the candidate Mr. / Ms. seeking admission to B.Arch in BACHELOR OF ARCHITECTURE program of R V College of Architecture , during the academic year , hereby undertake

1)

- a. To abide by all Rules and Regulations prescribed by the management of Rashtreeya Sikshana Samithi Trust (RSST), Jayanagar, Bangalore-11, Visvesvaraya Technological University (VTU), Belagavi, University Grants Commission(UGC), New Delhi, All India Council for Technical Education (AICTE) and R V College of Architecture, Bengaluru 560062
- b. To abide by all the rules pertaining to attendance and Continious Internal Evaluation (CIE) requirements prescribed by the University/Institution for the purposes of seeking eligibility to appear for the Semester End Examination(SEE) requirements.
- c.
